2. Fees for 1st quarter is as follows:.

3. Fees to be paid online (UBI) as offline fees will not be collected at school.

4. RTE candidates:

a. No fees for whom the reimbursement facility is not available in their department.

b. All working parents should bring a certificate from their department stating that fee reimbursement facility is not available in their department if they wish to claim fee exemption.

5. Fee exemptions, under RTE are allowed for those parents who are non Govt. employee and reimbursement of fee is not available from their department with an undertaking.

Documents to be produced at the time of admission for Balvatika-3.

- Certificate of proof of age in the form of a **birth certificate** issued by the authority competent to register births. (original & copy)
- A certificate that the child belongs to the **Scheduled Caste/Scheduled Tribe/EWS/OBC (Non-Creamy Layer)/BPL** wherever applicable, issued by the competent authority in concerned State Government/Union Government. SC/ST,OBC-NCL Certificate must be in the name of the child. (original certificate)
- A service certificate showing the number of transfers during the preceding 7 years duly signed and stamped by the head of office bearing the name, designation and other relevant particulars in block letters. (original certificate)
- A certificate of retirement for uniformed Defense employees. (original certificate)
- Proof of Residence (original certificate)
- Copy of Aadhar card
- For DA candidate, a certificate from the civil surgeon/rehabilitation centre or any other competent authority defined by the Government of India certifying he/she is a child with special need (CWSN). (original certificate).
- Self declaration duly signed by parent and declaration of distance from school to residence for RTE students .

Note: Physical presence of the child is mandatory for admission
